Good News:

Juul Settles Multi-State Youth Vaping Inquiry for \$438.5 Million



Juul Labs has tentatively agreed to pay \$438.5 million to settle an investigation by nearly three dozen states that focused on the company's sales and marketing practices that they claim fueled the teenage vaping crisis. The investigation found that the company appealed to young people by hiring young models, using social media to court teenagers and giving out free samples.
